ON APRIL 19TH, 1991, DEPUTY SEVERSEN WAS SEVERELY AND
PERMANENTLY INJURED WHILE ASSISTING BURNETT COUNTY SHERIFF'S
DEPARTMENT APPREHEND A VIOLENT ARMED SUSPECT.

MICHAEL SEVERSEN DIED FROM COMPLICATIONS FROM HIS INJURIES WHILE
AT HIS HOME ON MONDAY, APRIL 14TH, 2014, AT AGE 50.

A FULL HONORS LAW ENFORCEMENT FUNERAL FOR DEPUTY SHERIFF MICHAEL
J SEVERSEN WILL BE HELD AT THE ST CROIX FALLS HIGH SCHOOL, 740
MAPLE ST, ST CROIX FALLS, WI ON SATURDAY, APRIL 19TH, 2014, AT
2:00 P.M. VISITATION WILL BE HELD ON THE SAME DATE FROM 11:00
A.M. UNTIL THE TIME OF THE FUNERAL.
